

The Internal Assessment Mechanism

The internal assessment system of the institution is transparent and objective. At the beginning of the session, the students of the college are made aware of the university rules and regulations regarding the internal evaluation process through the annual Orientation Programme. Performance of the students is judged on the basis of continuous evaluation in classroom and as per directions of Chaudhary Ranbir Singh University, Jind. Internal assessment carries 20% of the total marks which is evaluated on the basis of the performance of students in class tests, assignments and attendance which carry 10%, 5% and 5% weightage, respectively. The results of these tests are declared to the students in the class. In case any student fails to appear in the class test or submit their assignments at the scheduled time, a special chance is given to them according to the university guidelines to submit their assignments or to take the class test.

NOTIFICATION

The Academic Council vide its Res. No.39 dated 05.08.2011, has approved the following provision regarding increase in the internal assessment from 10% to 20% in all under-graduate courses and M.A. Courses where there is no provision of internal assessment, w.e.f. the session 2011-12. The House examination shall stand scrapped automatically:

1. **For Under-graduate courses**

Internal assessment in all UG courses be increased from 10% to 20% in each theory paper based on the following criteria:

2. In the M.A. courses also where there is no provision of internal assessment, 20% marks will be earmarked for the internal assessment to be awarded on the above based criteria w.e.f. 2011-12. In M.Sc. and other courses wherein the provision of internal assessment of 20% or above is already in existence, the status-quo may be maintained.

Further necessary action may please be taken accordingly.
