3. The Superintendent-In-Chief will provide Invigilators / Assistant Superintendents, Clerk and other supporting staff to the Centre Superintendent as per requirement.
4. The Invigilators / Assistant Superintendents may be from regular / extension teachers of Government and Govt. Aided Colleges or approved teacher of self-financing colleges.
5. **The staff appointed must be relieved by Principal of college concerned, so that he/she can report to the Superintendent-In-Chief /Principal of concerned Examination Centre on 21-12-2023 up to 11:00 A.M.**
6. An Undertaking must be taken from the staff on duty that "No Relative of his / her is appearing in exam at concerned centre".

7. The Examination duty is mandatory as per DHE Letter No. 18/83-2018 UNP (1) dated 06/04/2018. Any appointed Examiner if refuse duty except Medical Reason certified by CMO will not be considered for Examination Duties for next one year.
8. The staff appointed on Examination duty will be paid remuneration and TA/DA as per CRSU, Jind norms.
